

# DAYCARE & BOARDING AGREEMENT



I understand that I am solely responsible for any harm caused by my dog(s) while my dog(s) is/are attending daycare at Paw Pals, Inc. (herein "Paw Pals"), whether to the Paw Pals facility, its employees or any other dogs.

I also understand that in admitting my dog(s), Paw Pals has relied on my representation that my dog(s) is/are in good health and have not harmed or shown aggressive or threatening behavior towards any person or any other dog. Although Paw Pals does not require dogs to have a vaccination for canine influenza virus (CIV), this is strongly encouraged and expenses related to the diagnosis and treatment of CIV are not eligible for reimbursement if the dog(s) has/have not received a current CIV.

I understand that when an older dog(s) is/are placed under the stress of being outside the normal comforts of home, it can cause dormant physical conditions to become active. I understand that it may result in a decline of health in the dog(s).

I further understand that due to the way dogs interact with one another, cuts and scratches can occur even though the dogs are carefully supervised at all times.

While my dog(s) is/are in the care and custody of Paw Pals and I am unreachable in the event of an emergency, I hereby authorize Paw Pals, its agents and/or representatives, to seek immediate veterinary care for my dog(s). I understand that all costs in connection therewith – veterinary, medical and otherwise – shall be my responsibility.

I release, indemnify and hold harmless Paw Pals, its employees and representatives, from any liabilities, claims and damages (including attorney fees and related costs) arising from or related to: (a) any breach of this agreement by me; (b) the inaccuracy of any statement made by me or in information provided to Paw Pals by me or about my dog; or (c) my dog(s) being at the Paw Pals facility or the services provided by Paw Pals to my dog(s), including for any injury, damage or death to, or caused by, my dog(s).

I certify that I have read and understand the rules and regulations set forth on the preceding page, and that I have read and understand this agreement. I agree to abide by the rules and regulations and accept all the terms and conditions of this agreement. If any provision of this agreement is held to be unenforceable, the remaining provisions shall continue to be enforceable and effective.

Although Paw Pals carefully screen all applicants, occasionally it discovers that the Paw Pals daycare or facility is not an appropriate environment for every dog. Paw Pals reserves the right to permanently remove a dog from daycare at any time.

Please initial acknowledging that you give permission to Paw Pals and its representatives to photograph, videotape or record images of your dog(s) in connection with the business of Paw Pals, and such images will be the sole and exclusive property of Paw Pals.

Payment due on day of service.



Client is responsible for payment unless 24-hour notification of absence from daycare/boarding is given.



Dogs not picked up within 30 minutes of closing, will be assumed boarding and we will impose an overnight boarding charge.



We will be **closed** on the following holidays and there will be an additional \$10 Holiday Fee: Labor Day, New Year's Day, Easter, Memorial Day, July 4<sup>th</sup>, Thanksgiving, and Christmas Day.



Boarding dogs must be dropped off by 2pm. Any dogs dropped off after 2pm will be charged a \$10 late fee.



Late fee: \$10 for every 15 minutes (or part thereof) past closing.



Packages are non-refundable.



All dogs who have a lapse in vaccinations, are required to wait five (5) days before attending Paw Pals



Dogs will be placed in crates for overnight boarding, unless prior arrangements due to extenuating circumstances are made with a Manager.
